



**ROHS - RESTRICTION OF HAZARDOUS SUBSTANCES**

The Schroff product line offers several product configurations to meet the requirements of the European Directive 2011/65/EU for Restriction of Hazardous Substances. This European Directive affects primarily the aluminum components that are finished with a gold chemical film process. This process uses a hexavalent chromium (Cr+6). An option for clear chemical film process using a trivalent chromium (Cr+3) has been added for those needing to meet this requirement.
